

#### **Investment Objective and Strategy**

The Fund seeks long-term growth of capital. The Fund invests in approximately 40-45 common stocks that the Fund's subadviser believes offer the best potential for earnings growth with the lowest risk of negative earnings surprises. When selecting investments, the Fund's seasoned investment management team takes a rigorous, three-step approach. First, it screens out those stocks that are the most volatile or are more likely to underperform the market. The stocks that pass the initial screening are evaluated to identify those that have the highest probability of producing earnings growth that exceeds investor expectations. From that pool of stocks, the team uses fundamental analysis to choose approximately 40-45 stocks that are believed to have the best growth and risk characteristics.

#### **Glossary of Terms**

Large-growth portfolios invest primarily in big U.S. companies that are projected to grow faster than other large-cap stocks. Stocks in the top 70% of the capitalization of the U.S. equity market are defined as large cap. Growth is defined based on fast growth (high growth rates for earnings, sales, book value, and cash flow) and high valuations (high price ratios and low dividend yields). Most of these portfolios focus on companies in rapidly expanding industries. The Russell 1000 Growth Index measures the performance of the large- capitalization growth segment of the U.S. equity universe. It includes those Russell 1000 Index companies with higher price-to-book ratios and higher forecasted growth values. The Russell 1000 Index is a subset of the Russell 3000® Index, representing approximately 90% of the total market capitalization of that Index. Indexes are unmanaged and do not reflect the performance of any particular security. Alpha is a measure of performance on a risk-adjusted basis. Beta measures market volatility; a benchmark generally has a beta of 1.0; an investment with a beta under 1.0 is considered less volatile. R-Squared measures the percentage of a fund or security's movements that can be explained by movements in a benchmark index. Standard Deviation is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. Sharpe Ratio measures reward vs. risk; a higher number is more favorable. Portfolio Turnover is reflective of quarter end.
